

City and county of residence: Monaville, Waller County

Education: Hempstead High School, 1987, and Blinn College, Texas A&M, 1991

Current occupation and relevant job experience: Prosperity Bank, 33 years. I have worked in the Hempstead and Waller Branch offices and have served as Banking Center president for the past 17 years.

Professional background: With 33 years of experience in local banking, I bring a conservative financial mindset to the SBEC board. Throughout my career, I have managed my local branch goals, including growth, employee supervision, budgeting and loan production, all of which will enable me to be an effective and active board member.

Cooperative vision and passion: I am excited to be part of a cooperative because everything is done for the benefit of the co-op and its members. Current occupation and relevant job experience: Vice president of manufacturing at Solugen

Professional background: I have worked as an operations support engineer and capital project manager supporting offshore oil production platforms and chemical refineries for ExxonMobil, Shell/ Saudi Aramco and Solugen, I've been responsible for ensuring the operating teams meet their goals and led the execution of several projects valued at greater than \$125 million that were delivered on time and on budget. The key challenges of my day-to-day job are nearly identical to the day-to-day challenges faced by SBEC.




KILOWATT-HOUR SALES




ASSETS
